SUBJECT: WIOA Formula Allocations for PY2025

The U.S. Department of Labor announced the states' WIOA Title I-B Program Year 2025 (PY25) funding amounts in TEGL 11-24. WIOA prescribes a specific formula for states to follow when allocating Title I-B funds to their local areas. Fund distribution to Idaho's service delivery areas (SDA) mirrors the federal formula designated by the state Workforce Development Council. State, local area, and SDA breakouts for Adult, Youth, and Dislocated Worker programs are shown in the table below.

The state's total WIOA Title I-B allocation increased from PY24 by \$1,086,377.
