SUBJECT: New Services in IdahoWorks

### Update:

- Supersedes WIOAB 12-19
- OJT-On the Job Training AND OJT- Registered Apprenticeship removed for youth participants.
- OJT-On the Job Training and OJT-Registered Apprenticeship was removed from Adult and Dislocated Worker credential

When adding a new service for a participant in IdahoWorks you are asked to answer "<u>does this</u> <u>service lead to a credential, employment or a measurable skills gain?</u>". Below is revised guidance that will assist with answering the question appropriately and selecting the potential results of the response. (See Reference A below)

### **Guidance:**

  This question must be answered. It cannot be left as NA. (See Reference A below)
