SUBJECT: Information Notice – WIOA Formula Allocations – PY2022

The U.S. Department of Labor announced in TEGL 9-21 the states’ WIOA Title I-B Program Year 2022 funding. WIOA prescribes a specific formula for a state to follow when allocating Title I-B funds to its local areas. Fund distribution to Idaho’s service delivery areas (SDA) mirrors the federal formula designated by the state Workforce Development Council. State, local area, and SDA breakouts for Adult, Youth, and Dislocated Worker programs are shown in the table below.

Unfortunately, the state’s total WIOA Title I-B allotment decreased from PY21 by \$671,954 (9.07%). Reductions by program are shown below.
